

- 1. The Name an Orchid lottery is organised and promoted by World Land Trust Ltd (registered charity 1001291), Blyth House, 3 Bridge Street, Halesworth IP19 8AB.
- 2. The lottery is open to anyone aged 16 years or over making a minimum donation of £10 to Name an Orchid, except employees of World Land Trust and their close relatives and anyone otherwise connected with the organisation.
- 3. By entering the lottery, entrants are indicating their agreement to be bound by these terms and conditions.
- 4. An individual may make multiple entries to the lottery; each entry requires a donation of at least £10. All entries have the same chance of winning, regardless of the level of donation.
- 5. Closing date for entry will be 12:00 on 15 December 2015. After this date no further entries to the lottery will be accepted. No responsibility can be accepted for entries not received for whatever reason.
- 6. The rules of the competition and how to enter are as follows: to enter the lottery entrants are required to make a donation of £10 through the Name an Orchid donation page. Once the donation has been made the donor will automatically be entered into the lottery.
- 7. All donations from the lottery will go towards World Land Trust's conservation project work in Ecuador.
- 8. World Land Trust reserves the right to cancel or amend the lottery and these terms and conditions without notice if circumstances arise out of its control.
- 9. The prize is as follows: the winner will be given the opportunity to name an orchid.
- 10. The prize is as stated and no cash or other alternatives will be offered.
- 11. The winning entry will be drawn from all valid entries received by the closing date by an independent person appointed by World Land Trust.
- 12. The winner will be notified by email within 28 days of the closing date. If the winner cannot be contacted or does not claim the prize within 14 days of notification, World Land Trust reserves the right to withdraw the prize from the winner and pick a replacement winner.
- 13. World Land Trust's decision in respect of all matters to do with the lottery will be final and no correspondence will be entered into.
- 14. The lottery and these terms and conditions will be governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England.
- 15. The winner agrees to the use of his/her name and image in any publicity material. Any personal data relating to the winner or any other entrants will be used solely in accordance with current UK data protection legislation and will not be disclosed to a third party without the entrant's prior consent.
